

The civil division represents plaintiffs and defendants in small claims actions and in consumer protection issues. The criminal division serves adults in misdemeanor cases and juveniles in felony and misdemeanor cases. LSIC also monitors and provides public education to the community on landlord-tenant, civil and criminal law. By providing assistance and representation to indigent persons, we further the administration of justice in the local courts and D.C. agencies. Additionally, we assist
