The majority of the civil legal work we perform is in landlord-tenant and housing cases, including eviction defense, rent control and subsidized housing-related matters in the landlord-tenant court and before administrative tribunals. We also represent respondents in civil protection order matters pending in the domestic violence branch of our local trial court. For a short period during the fiscal year, we operated an immigration defense program. Our criminal program provided representation to adults in misdemeanor trial and appellate matters. Finally, we provide representation to clients in
