HOUSING PROGRAM: RISING FOR JUSTICE (RFJ) ADVANCES HOUSING STABILITY AND PREVENTS EVICTION THROUGH ITS HOUSING ADVOCACY AND LITIGATION CLINIC (HALC), STABILIZING COMMUNITIES (STABCOMM) PROGRAM, AND TENANT JUSTICE PROGRAM (TJP). TOGETHER, THESE INITIATIVES PROVIDE CRITICAL LEGAL REPRESENTATION AND SOCIAL-WORK SUPPORT TO LOW-INCOME DC RESIDENTS FACING EVICTION, UNSAFE HOUSING CONDITIONS, OR BARRIERS TO STABLE HOUSING. DC'S ONGOING HOUSING CRISIS, MARKED BY SOARING RENTS, LOSS OF AFFORDABLE UNITS, AND WIDENING RACIAL DISPARITIES, HAS LEFT MANY TENANTS VULNERABLE TO DISPLACEMENT AND HOMELESSNESS. RFJ'S UNIQUE POSITION AS THE SOLE LEGAL SERVICES PROVIDER IN DC OFFERING IMMEDIATE LEGAL ADVICE AND EVICTION DEFENSE IN THE LANDLORD AND TENANT BRANCH OF DC SUPERIOR COURT UNDERSCORES THE URGENCY AND SIGNIFICANCE OF ITS WORK.

EXPUNGEMENT & RECORD SEALING: RISING FOR JUSTICE (RFJ) PROVIDES LEGAL REPRESENTATION AND HOLISTIC SUPPORT TO DC RESIDENTS SEEKING TO SEAL OR EXPUNGE CRIMINAL RECORDS. NEARLY 68,000 DC RESIDENTS, DISPROPORTIONATELY PEOPLE OF COLOR, LIVE WITH CRIMINAL RECORDS THAT RESTRICT ACCESS TO EMPLOYMENT, HOUSING, AND EDUCATION. BLACK RESIDENTS MAKE UP 43% OF THE CITY'S POPULATION BUT 86% OF ARRESTS, A DISPARITY THAT PERPETUATES CYCLES OF POVERTY AND EXCLUSION. THROUGH ITS CRIMINAL RECORD SEALING PROGRAM, RFJ ASSISTS CLIENTS IN NAVIGATING COMPLEX ELIGIBILITY AND FILING REQUIREMENTS, DRAFTING MOTIONS, COLLECTING DOCUMENTATION, AND PREPARING EVIDENCE OF REHABILITATION AND COMMUNITY ENGAGEMENT. RESPONDENT REPRESENTATION: RISING FOR JUSTICE (RFJ) OPERATES THE RESPONDENT REPRESENTATION PROGRAM (RRP) TO ENSURE DUE PROCESS AND EQUITY IN CIVIL PROTECTION ORDER (CPO) AND ANTI-STALKING ORDER (ASO) CASES IN DC. EACH YEAR, OVER 6,000 OF THESE CASES ARE FILED IN THE DC SUPERIOR COURT. PETITIONERS OFTEN RECEIVE LEGAL ASSISTANCE, WHILE RESPONDENTS, WHO FACE SERIOUS RISKS TO HOUSING, EMPLOYMENT, AND FAMILY STABILITY, ARE ALMOST ALWAYS UNREPRESENTED.

LAUNCHED IN 2018 AT THE REQUEST OF THE DC SUPERIOR COURT, THE RRP ADDRESSES ONE OF THE MOST SIGNIFICANT GAPS IN THE CITY'S CIVIL JUSTICE SYSTEM. JUDGES, ATTORNEY-NEGOTIATORS, AND COURT STAFF CONSISTENTLY AFFIRM THAT WHEN RESPONDENTS HAVE COUNSEL, CASES PROCEED MORE EFFICIENTLY, OUTCOMES ARE FAIRER, AND COMPLIANCE WITH COURT ORDERS
